MEMORANDUM OF UNDERSTANDING BETWEEN

U.P. RAJARSHI TANDON OPEN UNIVERSITY

INSTITUTION OF FIRE ENGINEERS (INDIA)

PREAMBLE: With the globalization and opening up of Indian economy to outside world, competition among industries has become stiff. To solve their problems in various business, engineering and related domains, it is important to bridge the gap between industry and the academic institutions. Better interaction between technical and professional institutions and industry is the need of the hour. This will have great bearing on the curriculum design, exposure of students to industrial atmosphere and subsequent training and placement of young graduates and post-graduates in industries across the country.

This Memorandum of Understanding (hereinafter called as the 'MOU') is signed on 2.1. day of Setate 2023 at New Delhi, India.

By and between:

The U.P. Rajarshi Tandon Open University (UPRTOU), Prayagraj, The First Party, (hereinafter referred to as the University) having the main campus in Phaphamau, Prayagraj India, hereafter referred to as "UPRTOU" which expression, unless repugnant to the text or context thereof shall include it successors, affiliates and permitted assigns, of the First Part.

Institution of Fire Engineers (India), 719, 7th Floor, Jaina Tower - I, Janakpuri district Centre, New Delhi - 110058, The Second Party, (hereafter referred to as "IFE (India)") which expression, unless repugnant to the text or context thereof shall include its successors and permitted assigns of the Second Part.

And have hereby decided that both parties would adhere to the following responsibility charter listed below:

Section-1.0: MOU Signatories:

The signatories of the MOU will be UPRTOU and IFE (India)

Section-2.0: Objectives and Engagement

The scope of the Memorandum of Understanding is as under -

- To jointly conduct lectures/ workshops/ symposia/ conferences/ other similar events in a) mutually agreeable areas at the state/national/international level.
- To jointly develop short term courses (Certificate/Diploma) for skill enhancement. b)
- c) To develop training programme for in service offices.
- d) To undertake joint field visits, training, internships etc. for students for capacity building.
- To jointly undertake consultancy work. e)
- f) To undertake joint study/research projects on mutually agreeable terms.
- To develop reading materials. 2)
- h) To exchange resource person for various academic programmes.

Section-3.0: Financial & Liability:

The administrative liability will be restricted to the respective personnel of both the Institution, that for each assignment of work to be undertaken by the parties hereto under this MOU, the extent of services by each party and fee for services to be rendered, if any, and the terms of payment shall be negotiated and be agreed upon by mutual consent. Out of generated funds and participation fees.

There shall be not be any financial liability on either of Institutions. Seminar/conference/Workshops will be conducted jointly through generated funds from various agencies and participation fees.

Section-4.0: Duration of Engagement:

This MOU will be valid for 5 years from the date of signing. Once the initial period of 5 years is over, the MOU will be extended for a further period of 5 years, with suitable changes (as per applicability) with mutual consent. If for any reason, anyone entity of the MOU is desirous not to continue with the engagement. The same can be done by giving advance notice of one month.

Section-5.0: Dispute & Redressal:

That this MOU signed between the parties shall cease to exist after mutual agreement between both the parties at any point of time (within its validity period). However, both parties have the responsibilities for completing the undertaken activities faunched as per this MoU.

In case of any disputes of any kind between the UPRTOU and IFE (India), the decision of the Vice-Chancellor of UPRTOU shall be final and binding on both parties.
