





Memorandum of Understanding (MoU) **Between**

The representatives of U.P. Rajarshi Tandon Open University, Prayagraj (U.P.) and Mahatma Gandhi Chitrakoot Gramodaya Vishwavidyalaya, Chitrakoot, Satna (M.P.) agree to this Memorandum of Understanding. The Memorandum of Understanding (MoU) establishes the following:



1. Objective of the MoU.

- a) To establish a mutually beneficial relationship built on academic and cultural cooperation.
- b) Areas of Cooperation between U.P. Rajarshi Tandon Open University, Prayagraj and Mahatma Gandhi Chitrakoot Gramodaya Vishwavidyalaya, Chitrakoot, Satna (M.P.) include the academic research and cultural interactions among faculty exchange of researchers and students, for research publication, academic programmes, cultural and research project internship.
- c) To conduct study tour, a mutually agreed in writing between both party's prior commencement of this activity.

2. Goals and Forms of Collaboration.

The signing Universities agree to provide opportunity, as appropriate for the following activities towards the completion of the objectives of this MoU.

- a) Joint collaboration of students and /or researchers with the objective of offering courses and realizing research, internship in areas mutually agreed upon by both institutes through prior invitation through and in accordance with the procedures and expectations established by each Institute and specific department.
- b) Exchange of books publications cultural programme, academic projects, course information seminars, lecture demonstration for workshop, conferences and other data and information of common interest.
- c) Lectures of faculty members on special topics.
- d) Organize Joint activities will be realized through the manual agreement and clearly established conditions and mutual obligations of the appropriate institute entity.
- e) Provide research guidance and extend facilities to conduct research leading to research degrees.

3. Implementation of the Memorandum of Understanding

The objectives of the MoU will be implemented and regulated in the following manner.

Students exchange. i.

- a) Student and research scholars may visit the corresponding departments of these institutes after finalizing a mutually acceptable schedule.
- b) All the expenses shall be the direct responsibility of the students concerned subject to any agreements on payment arrangements made by either institution with its own students including
 - 1) Travel expenses, 2). Reprographic and internet Usage Expenses,
 - 3). Required Student Services fees at the host institution, 4). Books





and academic supplies, 5). Administrative fees, if any and cultural events.

Exchange of Researchers. ii.

With the objective of strengthening ties through joint projects, internship research activities, cultural of both research guide, guidance and facilities under the MoU. The researchers will maintain their status as student's research scholars at their home institution for the duration

- a) The researchers will maintain their status as a student research scholar at their respective bonafide university for the duration of
- b) The researchers will be allowed to make use of the books, publications, theses and other research facilities including research guide available in various department of both universities with the prior approval.

Research and resources. iii.

U.P. Rajarshi Tandon Open Uriversity, Prayagraj (U.P.) and Mahatma Gandhi Chitrakoot Gramodaya Vishwavidyalaya, Chitrakoot, Satna (M.P.) agree to promote remote research and realize collaborative projects, giving priority to interdisciplinary works.

4. Duration and Residence of MoU.

- a) The agreement will take effect from the date of its signing changes to this agreement shall be made by mutual consent between both institutions. In case of disagreement, the institute willing to department from the agreement shall, wherever possible, give two months notice of its intention to do so. The Agreement shall be reviewed after a period of three years.
- b) There is no financial and legal commitment on the part of both the parties to take up- any program mention in this MoU. If there is any financial consideration, it will be dealt separately as per proposer's parent institutional administrative and financial approvals or as per mutual agreement.
