As you are aware, NITI Aayog has undertaken an initiative to develop a Mentorship Framework for students belonging to vulnerable sections across school, higher, and vocational education. In this regard, a Working Group has been constituted under the Chairpersonship of Dr. V. K. Paul, Member, NITI Aayog, along with a Sub-Group on 'Mentorship framework for students in Higher Education belonging to Vulnerable Sections' under the Chairpersonship of Dr. M. N. Srinivas, Director, AIIMS, New Delhi, to suggest a broad framework that may be suitably adapted by higher educational institutions as per their specific requirements.

2. As per the recommendation of the sub-group, NITI Aayog is conducting- i) Need Assessment on Mentorship for students in Higher Educational Institutions (HEIs), and ii) Study of the mentorship ecosystem in HEIs. For this purpose, two structured questionnaires have been developed (one for students of HEIs and another for faculty of higher educational institutions) for primary data collection.

3. I shall be grateful if you could kindly facilitate the following:

- Circulation of the Need Assessment Questionnaire among a minimum of 5000 students of at least 500 HEIs under your purview.
- Circulation of the Questionnaire on the study of mentorship ecosystem in HEIs to be filled in by the faculty of a minimum of 500 HEIs.
